#### JUDICIAL OFFICES

Filing dates: Monday, January 4, to Friday, January 15, 2010. Supreme Court Candidates file with the Secretary of State. The filing fee is \$300. All candidates filing for judicial office must present identification which indicates address on Declaration or Acceptance of Candidacy. The fee must be paid by cash, cashier's check or certified check to the Secretary of State.

#### NON-JUDICIAL OFFICES

Filing for non-judicial federal, state, and county offices will begin at 8:00 a.m., Monday, March 1, 2010 and end at 5:00 p.m., Friday, March 12, 2010. Federal and State offices file nomination papers with the Secretary of State. All County offices file with the County Clerk. All candidates filing for office must present identification which indicates residence address on Declaration or Acceptance of Candidacy. Filing fee for County Office is \$100, School Trustee, TV Boards and West Wendover Recreation Board is \$30. The fee must be paid by cash, cashier's check or certified check.

The Primary Election will be held June 8, 2010 and the General Election will be held on November 2, 2010.
