NOTICE IS HEREBY GIVEN that pursuant to an order of the Board of County Commissioners, County of Elko, State of Nevada, made at a regular meeting of the Board on the 1st day of February, 2017; said Board will receive separate, sealed bids for the construction of the South Fork Road- Park Entrance to Causeway Reconstruction Project, PWP-EL 2017-075.

This project is located in South Fork State Park and commences from the end of the existing pavement at the main entrance to the state park and will extend southerly 1.75 miles to the intersection with the causeway, accessing the western side of South Fork Lake.

Sealed bids will be received by the Board of County Commissioners at the Office of Elko County Highway Department, 994 River Street, Elko, Nevada 89801 until 10:00 A.M. (Pacific Daylight Savings Time) on the 27th day of March, 2017. The Bids will be publicly opened and read aloud at 10:05 A.M. (Pacific Daylight Savings Time) on the 27th day of March, 2017 at the same location.

Contractors are advised that the estimated cost for the project will require contractors to comply with the requirements for a prevailing wages job. Contractors are advised to pay particular attention to Section 17 of the Instruction to Bidders in the Project Specifications in order to accurately calculate the wage rates contained in their bid. No pre-bid meeting is scheduled at this time.

The successful bidder will be required to comply with N.R.S. Chapter 338 Public Works Projects.(Pursuant to NRS 338.1379, and 338.1382.)
