**NRS 19.013(5) No fee may be charged to any attorney at law admitted to practice in this State for searching records or files in any office of the clerk. No fee may be charged for any services rendered to a defendant or the defendant's attorney in any criminal case or in habeas corpus proceedings.**

**NRS 19.035 Fees not to be charged or collected for services rendered certain governments or officers. A county clerk when acting as ex officio clerk of the district court shall neither charge nor collect any fee for any service rendered by the county clerk to:**

1. The State of Nevada;
2. The county of which he or she is county clerk;
3. Any city or town within that county;
4. The school district of that county;
5. Any general improvement district which is located within that county; or
6. Any officer of the State, that county or any such city, town, school district or general improvement district in the officer's official capacity.
